- **Status of Remove Author:** [Rahmat fadhli] has agreed to be removed from the authorship list to align the publication with the officially documented research team and

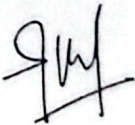
relevant institutional reporting requirements. This change is administrative in nature and does not indicate any authorship dispute, research misconduct, or concern regarding his scholarly contribution.
